ANSWER TO AFFIRMATIVE DEFENSES


Now comes the plaintiff, Dr. E. Kwan Choi, by his attorneys, Michael D. Poulos, P.C., and, answering the affirmative defenses of K. Richard Keeler, Georges Michelson-Dupont, Mo Siegel, and Gard Jameson, states as follows:


Wherefore, the plaintiff prays that the court find in his favor and award him judgment as requested in his complaint, together with costs herein.
